## 2.3.3 Hot water heating

#### David's comments

- Concerned about the sustainability of hot water electric heating systems
  - Do these systems utilize Abbott steam and condense it to hot water? If these systems do not utilize Abbott steam, and they become the status quo for heating campus buildings, this would make the main byproduct of Abbott co-gen obsolete. This would waste tremendous amounts of energy.
  - Do hot water heating systems expend more power than heating systems which utilize steam? I can imagine hot water systems require Abbott steam to be condensed, and power would be required to re-heat the hot water to meet building heat demands. This sounds to me like it could end up using more energy than steam heating systems.
  - Where will the electricity to power these hot water systems come from? Will they all use power from the campus grid? Will buildings with rooftop solar be able to provide some energy toward the electric heating system?
  - If hot water heating becomes the status quo, would it be more energy efficient for Abbott to produce hot water instead of steam? Is there a way to replace the steam infrastructure (i.e. turbines and pipelines) with hot water counterparts?
  - Is hot water heating truly the most energy efficient building heat option? Are there any alternatives being considered?

#### F&S concerns

\$600,000 per building and about 175 buildings
