Per the Carbon Credits MOU, the two of you are responsible for evaluating and approving the use of Carbon Credit sales funding. The Carbon Credit funding currently has \$1,030,721.85 available to allocate.

Please approve: iCAP Portal funding support for FY20 to FY23, in the amount of \$50,000 Also, please approve: the attached MOU for the iCAP Portal ongoing improvements from FY21 to FY23

FY20 (current year): \$5,000 – already verbally approved FY21: \$15,000 – already verbally approved FY22: \$15,000 FY23: \$15,000

Total from Carbon Credit Sales: \$50,000

In FY19, F&S and iSEE jointly funded the iCAP Portal maintenance and improvements from the Carbon Credit Sales Fund. For FY20 and FY21, we have already discussed sharing the costs again, with a limited amount of \$5K for FY20 and the standard amount of \$15K for FY21. However, the existing MOU between MSTE and iSEE is expiring this June, so I have drafted an updated MOU that includes F&S and is for three years from FY21 to FY23, at the standard \$15K/year. Ximing, Meredith and I reviewed this MOU and included the large scale improvements planned for the next three years.

This will allow us to continue improvements to the iCAP Portal and continue to enhance the usability and impact of this well-used resource.
