According to the Hope Center Survey (2021) 30% of students at four-year universities claimed they were food insecure. Through this project, students are able to grow their own nutritious food thus providing themselves with a sustainable way to meet one of their basic needs. This project takes it a step further and provides an opportunity for all students, not just able bodied students, to grow their own healthy food. By providing a space for all students to garden, they not only grow their own food, but they also can plant native plants to support the environment. When a student has their basic needs met, they can then concentrate more on their studies and helping their community.

30. Provide a detailed project description:

(In 400 words or less, describe your project. What does your project hope to accomplish? What are your project's deliverables?) \*

We aim to enhance sustainability and accessibility for all students and residents living in university apartments by providing a sustainable opportunity to produce their own food. This project would establish a permanent location for all students and their dependents, not just able-bodied individuals to garden.

This project will create a 30 foot by 50 foot space made out of decomposed crushed granite located near the Orchard Downs Community Center with eight raised garden beds on it. The garden beds will be made out of wood and constructed within Facilities in University Housing. A water spigot will be installed and a water line run to the area. A black chain fence will surround the space to keep wildlife out and to support plants. Soil and a bench will be donated from University Housing Facilities for the space. Tools for gardeners will be provided by Family & Graduate Housing. The raised garden beds will be used at least six months out of the year by students and residents living in Family & Graduate Housing. Any future maintenance of the area will be handled through University Housing Facilities. This project will be accomplished in partnership with University Housing Facilities and maintained for many years into the future.

The proposed budget has increased from Step 1 due to the addition of the installation of a water line and water spigot, and creating an accessible path from the sidewalk to the area the raised garden beds are on.

## 31. Environmental Impact:

(In 200 words or less, how does your project increase environmental stewardship at UIUC? If applicable, what is the carbon, water, waste, and/or energy savings?) \*

The environmental impact will be reduced through sustainable gardening by reducing carbon emissions and increasing carbon storage in soil and plants. By students growing their food, there will be less food waste in landfills and reduced emissions by not using transportation to buy their food.

This project will impact many students living in the apartments by providing them an alternative to buying their own food, as well as making gardening accessible to all students and not just abled-bodied ones. Students will be able to use the raised garden beds six months out of the year.

Student interns and graduate assistants will also play a part in assisting the accessible gardens through hours of programs and informational sessions every year. We have a current partnership with the Community Health Program at the University of Illinois Urbana Champaign. Through this partnership, student interns will devote at least 10% of their 250 hours to creating content on sustainable practices, which includes gardening for the thousands of residents living in the apartments at Family & Graduate Housing. The student Graduate Assistant will also devote 10% of their hours to programs and events on sustainability.
